The EZCT is a microprocessor-based, current-transformer test set. This rugged and portable test set can perform the current transformer (CT) excitation, CT current-ratio, and winding polarity tests. Current transformers can be tested in their field-mounted configuration, eliminating the need to remove bushings or current transformers from the host equipment. The EZCT is capable of outputting 50 Vac at 2A and 200 Vac at 2A.

The EZCT-10 has all the features of the EZCT, but uses a heavy-duty transformer to perform the CT excitation test. It is capable of outputting 50 Vac at 10A and 200 Vac at 10A.

The EZCT and EZCT-10 have been in production since 2001, and over 1100 units have been sold world-wide.
